17th December Crown Court Hearing to Extend IPP

I get called out to see the prison housing officer re bail hostel and daily reporting to police station etc, should I get bail on this Thursday, 17th from Cardiff Crown court.

He is perplexed as to my **MAPPA Status level 3 (nasty offences)** as there is no record on the prison system of it or for dealing with me, due for release, if my 8th Cardiff judge is so minded!

He explained the "HIGH RISK" stuck on my cell door meant I was a 'mental health risk' not a MAPPA (**Multi Agency Public Protection Arrangements**) police/probation/prison care plan. Interesting, when it took a psychiatrist from High Security Ashworth Hospital (the 32nd doctor in this scandal) to make Dr Tegwyn Williams of Caswell South Wales Forensic Service to retract any idea (see his reports to obtain a 1983 Mental Health Act, Section 35) I should have been shipped to Ashworth, IPP, long ago!

Interesting, in that the psychiatric reports by MAPPA, Caswell Clinic and this prison, before I was sectioned, are now in my 'hot and sweaty' thanks to FOI and DP Acts, all documents deliberately 'withheld', at the time, from the judges of Cardiff courts.

Judges, Hughes, Morris, Llewellyn Jones, Cooke, Rees, Vosper and Jones in the criminal court and trial judge, His Honour Seys-Llewellyn QC, in the 17 year running civil damages claim for malfeasance/false imprisonment/conspiracy etc., all now know about this and aspects of my defence, yet to be disclosed, on my MAPPA telephone surveillance following the falsification of the 25th Feb 2009 Chief Constable's sworn affidavit.

But while the enemy have lost the psychiatric argument, for the moment, I am not holding my breath, they having obtained an **IPP conviction without trial**, of indeterminate prison length, then what dirty little bit of scheming are the South Wales Police up to now with the civil action so close, in January and the Chief Constable's retirement just a few days away?

Yesterday, maybe, when I was punished for trying to pay a lawyer by cheque and now banned for 3 weeks from my own cash to use the telephone or buy stamps is an indication of things to come?

Meanwhile, I have notified Cardiff Crown court of the recorded reason for my arrest in June, contrary to what is on the Indictments and disclosed the proof to an outside police force that, in turn, as with MP, Welsh Assembly, IPCC and South Wales Police Authority, continue to ignore me.


The private criminal prosecution returns to Cardiff Magistrates in January, relabelled as Barbara Wilding, to face conspiracy charges but do we really differ from Stalin's old regime when simply seeking justice?
