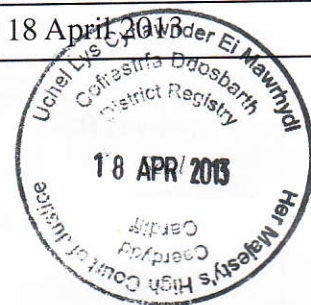

Upon the Claimant, being a litigant in person, asking to be allowed to record the ORAL evidence of Mr Steven Smith in these proceedings and indicating that he wishes thereby to be able to make a note of the evidence of the witness

IT IS ORDERED THAT

1. The Claimant is permitted to make a recording of the evidence of the witness for the purpose only of himself making a note of the evidence for his own use in the civil proceedings in the present actions and for the purpose of making submissions in the present actions..
2. The Claimant is not permitted to make use of the recording for any other purpose, and
3. The Claimant (i) shall not use the recording for any other purpose than that of use in the civil proceedings in the present action (ii) shall not by whatever means pass the recording or a copy of it to any other person and shall not publish the recording by whatever means or to any other person or persons or generally and in particular shall not publish or transmit it or a copy of it on his own or another website or by media communication of any kind and (iii) shall not use the recording for the purpose of any future private prosecution or application to a criminal court.
