HARRASSMENT

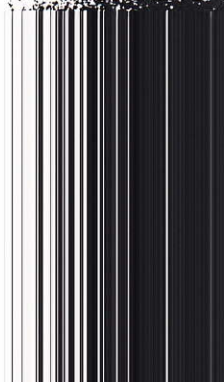
Further to my letter of 10 May 1993 further and better particulars have come to my notice to cause me to see Inspector Price today on the subject of harrassment.
