KIRK Again MR REEVES have you been in the company of Mr KIRK at all times during...

DC KNIGHT Who has access to place entries on your website?

DC KNIGHT Are you responsible for advertising this weapon and ammunition for sale?

KIRK (NO REPLY GIVEN)

DC KNIGHT When was the advertisement placed on the website?

KIRK (NO REPLY GIVEN)

DC KNIGHT Was the gun and ammunition sold as a result of it being advertised on the website?

KIRK (NO REPLY GIVEN)

DC KNIGHT If so, when was it sold?

DC KNIGHT I think there is somebody knocking on the door, just for the purpose of the tape, somebody has just knocked the wall so we're just go and enquire as to what's happening...

DC KNIGHT In relation to the continuation of this interview I feel
that, I've just mentioned Mr KIRK appears to be
fatigued which is understandable because its been a
long day so for that purpose we will conclude the
interview at this point, is there anything you wish to add
or clarify in connection with what's been said during
this interview Mr KIRK, do you wish to say anything
prior to the tapes being removed from the recorder?

KIRK I would like to have a copy of my statement for this while I am in custody, I would like to have a copy of it

DC KNIGHT And the statement you are referring to is that the prepared statement that you referred to in the initial interview?

KIRK Yes

DC KNIGHT Okay and does that statement bear any relevance to this investigation?

KIRK I answered that question a few hours ago

DC KNIGHT I appreciate that but if it does not have any bearing on this investigation then it won't be, won't be entered as evidence into this investigation at the moment

KIRK I gave you an unequivocal answer to your question several hours ago, this is the third time I have asked for a prepared statement for why I am in custody this evening

> DC KNIGHT I appreciate that Mr KIRK but I must repeat that if the prepared statement you are, could you confirm if the prepared statement your referring to has any relevance to this investigation?

KIRK

DC KNIGHT Sorry?

KIRK

DC KNIGHT Can you explain what you mean please?

KIRK

(NO REPLY GIVEN)

DC KNIGHT Is the statement your referring to directly relevant to the offences which you are being investigated this evening?

KIRK

Why am I in custody?

DC KNIGHT You are in custody because you have been arrested for two offences which was explained to you in the initial interview, one offence of unlawfully possessing a firearm and ammunition and the second offence of making threats to commit criminal damage at a premises situated at Dolman's Solicitors on Friday 19th

June 2009, the purpose of you being in custody is for us to obviously, for us to have interviewed you in respect of those matters and for us to obtain any evidence by questioning and carry out any additional enquiries whilst you are in custody

KIRK

DC KNIGHT Does the relevant statement, my apologies does the prepared statement to which you have referred I agree three times have a direct bearing on the two offences for which you are in custody?
